History

Richard Joseph Goldstone is a South African former judge. He served on the Transvaal Supreme Court from 1980 to 1989 and the Appellate Division of the Supreme Court of South Africa from 1990 to 1994. He served as Justice of the Constitutional Court of South Africa from 1995 to 2003.

President FW de Klerk appointed him on the 24 October 1991, to head the Goldstone Commission to investigate incidents of public violence and intimidation in South Africa prior to the 1994 general election. Between 1991 and 1994 the Goldstone Commission presented reports and recommendations relating to the nature, causes and persons involved in the numerous incidents of public violence and intimidation during that period.

The Institute for the Study of Public Violence, also known as the Goldstone Institute, was established in 1993 with the aim to document and research the work of the Goldstone Commission of Inquiry Regarding the Prevention of Public Violence and Intimidation. In 1994, after the closure of the Goldstone Commission, the Institute was re-constituted and became the independent non-governmental Human Rights Institute of South Africa (HURISA).
